Consultation on the new global GBV AoR strategy

Rational/purpose

Why is the session relevant/useful for field coordinators? What are the gaps/opportunities?

The GBV AoR strategy 2018-2020 is due to end at the end of this year. The consultation process will be ongoing for 6 months, including consultation sessions with humanitarian actors, GBV actors, GBV AoR Core members, donors, and field coordinators. This session is part of overall consultation for GBV AoR Strategy 2021-2024. Views and inputs by field protection cluster and AoR coordinators are an integral part of the consultation process, as part of participatory and bottom-up approach, as our GBV AoR aim is to ensure a field-oriented approach to GBV prevention, risk mitigation and response.

The coordinators will be engaged in an interactive session, facilitated by the strategy consultant, making sure their views and concerns are included in the process. Select topics will be discussed in breakout groups to gather input on participants' views on specific thematic areas, such as partnership and localisation, male survivors and MHPSS programs and the role of other protection actors as it related to GBV.

- Identified gaps and challenges in the field
- A written report on the consultations by the strategy consultant
